REGULATION

• The A.P.S. "International Diatonic Alliance" (I.D.A.) of Torre Orsaia (SA) - Italy, in collaboration with the "P. I. Tchaikovsky", the Calabria Region, the Municipality of Fuscaldo (CS), Musicalidus and the "A. Piazzolla", announces and organizes the "EDI 2023 WORLD DIATONIC ACCORDION AWARD" on 2nd and 3rd SEPTEMBER 2023.

• The competition will take place in FUSCALDO (CS).

• All eligible candidates for IDA competitions valid as a 2023 selection may take part in the competition.

• Registration is set at €40.00

• The competition will be divided into the following categories:

STUDENT TRADITIONAL (up to 4 bass instruments and 2 vocal files)

CAT A - born from 2015 to today (max 5 minutes)

CAT B - born between 2012 and 2014 (max 6 minutes)

CAT C - born between 2009 and 2011 (max 7 minutes)

STUDENT WORLD (all types of diatonic)

CAT D - born from 2012 to today (max 8 minutes)

CAT E - born between 2009 and 2011 (max 8 minutes)

TRADITIONAL JUNIOR CONCERTISTS (instruments up to 4 basses and 2 rows to singing)

CAT F - born between 2005 and 2008 (max 8 minutes)

WORLD JUNIOR CONCERTS (all types of diatonic)

CAT G - born between 2005 and 2008 (max 10 minutes)

SENIOR TRADITIONAL CONCERT PLAYERS (instruments up to 4 basses and 2 lines to singing)

CAT H - born from 2004 onwards (max 10 minutes)

WORLD SENIOR CONCERTS (all types of diatonic)

CAT I - born from 2004 onwards (max 12 minutes)

PREMIO IDA 2023

- *Competitors can only participate in one category of the competition.*
- *Competitors must perform a maximum of two free-choice pieces, and must perform within the limit of the playing time allowed according to the category to which they belong.*
- *Competitors with instruments of the "major and minor" type with no more than 2 rows of vocals and 4 basses can be included in the Traditional section.*
- *The jury will express its evaluation in twenty-fifths (with decimals). The highest and lowest rating will be deleted. The votes cast by each member of the jury will be made public.*
- *The commission's judgment is final.*
- *The IDA board can intervene and make changes and/or additions to the program and the regulation if there is an imminent need, in order to guarantee the moral integrity and transparency of the competition.*
- *Participants must complete the appropriate registration form, no later than 27 AUGUST 2023 on the website www.internationaldiatonicalliance.com*
- *Enrollments are limited in number: upon reaching 200 enrollments, enrollments will be automatically closed.*
- *To complete the registration, the competitor must make a bank transfer to "ACCADEMIA ASTOR PIAZZOLLA" – IBAN: IT 34 N 03698062310000005447 – once the bank transfer has been made, send the receipt to internationaldiatonicalliance@gmail.com*
- *Consult the IDA website www.internationaldiatonicalliance.com to keep up to date or ask for any info via our web chat.*
- *The competitor must present himself (provided with an identity document) at the secretariat for confirmation of participation. The competitor who does not appear at the second call will be excluded from the competition.*
- *All participants who have achieved the highest score in their category must present themselves to the ceremony of the award ceremony and then perform one of the pieces performed during the competition, under penalty of elimination and therefore the revocation of the award.*
- *The hearings are public. Anyone who fails to respect silence during the auditions of the competitors will be warned and expelled if they repeat it.*
- *In the event of Special and/or cash prizes being awarded, a review of the participants with the highest score in all categories will be carried out, with a pre-established commission. The criteria for the replay will be decided by the IDA board according to the needs of the moment.*
