VADEMECUM FOR THE COMMISSION

1. The President I.D.A., before starting the hearings, reminds the members of the COMMISSION about the rules.
2. the President of the commission, on the recommendation of the secretary, has the right to interrupt the performances that exceed the time foreseen by the regulation, taking care to choose the best moment (end of movement, end of piece, etc.)
3. The President of the Commission dissolves, with his own vote, any ex-aequo situations relating to the highest score in each category. In exceptional cases, consult the artistic director, or the I.D.A. President, then the members of the board of directors.
4. The commission will deliver to the secretary its own scoreboard (signed) at the end of the hearings. The secretariat will transcribe the votes on the final table to be able to draw up the list of votes, eliminating the lowest and highest votes from the averages of each competitor (this is to avoid any corruption).
5. The commission is required not to vote for candidates with whom they have family, personal or educational relationships.
6. The commission can cast votes for candidates from its own country.
7. The committees, without too much rigidity, are asked not to communicate with each other, not to sit too close and not to use cell phones.
8. No official meetings are scheduled and each member of the commission will have to wait in the secretariat for the final minutes for acceptance and the signature of the President for the results before publication.
9. The members of the commission will be informed of their category to which they belong, a short time (days) before the start of the competition.
10. The members of the commission must inform the organization of their availability by e-mail in time, under penalty of exclusion from the commission in the foreseen competition.

Membership for commission technicians:

The cardholder is aware that the board of directors of the association avails itself of the right to approve the granting or impediment of obtaining the card.

In the case of granting the card to the applicant, the cardholder will be registered in the register of registered technical examiners, therefore he can be part of the commissions during the competitions subject to his availability and to be aware of the regulations issued by the board of directors of the association, and therefore , physically obtain the card.

The board of directors of the association avails itself of the right to refuse the membership if the applicant does not prove that he has the requisites envisaged, therefore, in the case, to withdraw the card and eliminate the card from the register of registered technical examiners. Therefore he will no longer have the right to be part of the I.D.A.'s commissions.

Creation of membership cards for technical expert examiners (members will be recognized annually in order to be included in the jury, evaluated by the board according to various criteria).

Registration fee for expert examiners is free. A physical card will be issued.

Each member can propose and organize selections for the ida prizes, as can also propose new members, obviously with a resolution of the board of directors.

Those who do not have the criteria established by the board cannot be registered.

Technical members cannot participate in competitions.

People who have degrees in other instruments, who have adequate knowledge of the diatonic accordion, can be registered.

The commission will be drawn for each competition, and must be composed of a minimum of 7 to a maximum of 9 elements. In exceptional cases, the IDA management will decide.

The Commission President is chosen by the IDA Board of Directors.

Evaluation method:

The votes will be indicated from 18 to 25 with the possibility of inserting decimal numbers.

The lowest and highest grade will be eliminated from the average of each competitor (anti-corruption

In the case of assignment of Special Prizes and / or in cash, a re-listening of the participants with the highest score of all categories will be carried out, with a pre-established commission. The criteria for re-listening will be decided by the IDA board based on the needs of the moment

Selections:

At each selection competition, participants with a score equal to or greater than 20/25 will be selected

Foreign participants who want to select themselves can send a video with their performance

(respecting the maximum time indicated for each category) to the board, which will decide whether or not to select the competitor.

For foreign competitors, various selection methods can be adopted, with a resolution of the board of directors.
